

On March 13, 2020, President Trump declared a nationwide emergency pursuant to Sec. 501(b) of Stafford Act, increasing federal support to the Department of Health and Human Services (HHS) in its role as the lead federal agency for the ongoing Coronavirus 2019 (COVID-19) pandemic response. Under this declaration, FEMA, in coordination with HHS, will assist state, local, tribal, territorial governments and other eligible entities with the health and safety actions they take on behalf of the American public.

In order to maintain potential eligibility for reimbursement for management costs or direct project-related costs, all cost-related documentation must be collected and retained (e.g. procurement process, contracts, invoices, timesheets and payroll information, fringe benefit calculations, equipment and vehicle usage logs, materials records and inventory, rental and lease agreements, etc.). All Federal, State and local procurement laws must be followed and documented. The applicant must comply with relevant sections of the Public Assistance (PA) Program and Policy Guide and other applicable Federal and State regulations. All or part of these services may be eligible for FEMA Public Assistance.

COVID-19 WORK TRACKING SMART FORM

We will deploy user-friendly COVID-19 response tracking smart forms. Collecting data with the smart form can be completed from your web connected computer or mobile device.

Results and data collected on the form are submitted to your AGO GIS web account and available to your team in the office, field or at home. The COVID-19 response form can be used to track time, cost, and location of COVID-19 response activities. For example, you can easily map locations and capture information related to cleaning equipment and facilities.

As part of this service, our team will activate your "COVID-19 Response Form" that includes up to 15 questions for tracking reimbursable activities. REPORTING

Data collected with the COVID-19 Response form can be aggregated and reported using your AGO GIS web account. Our team will deploy an easy to use reporting tool that will allow your organization to quickly create a formatted report that summarizes the reimbursable response efforts. This will allow your organization to generate a report that can be submitted to the COVID-19 FEMA PA Portal support documentation section.

COVID-19 RESPONSE MAPPING

Our team will work with your organization to deploy web maps, dashboard apps, and story maps, to communicate current support activities to the public community. These web maps and apps will be deployed to communicate internally or share important information with the public. GIS can be used to map your community's vulnerable population and resources. Resource mapping can include public facilities, testing centers, medical resources, equipment, goods and services, and more.
